One Md. Abdul Khalil (ASI CDO/IE attached with Cyber Lab, IE District) lodged a written report to OC HNG-PS Stating that that on 27/09/2025 at around 09:00 am, acting on reliable information received from Inspector Md. Rajib Khan, In-Charge Cyber Lab, Imphal East District, regarding the presence of recruiter of UG group cadres in and around the Mantripukhri area, a joint operation was launched. A combined team comprising Cyber Lab personnel, assisted by a CDO/IE team, carried out the operation under the command of Shri Khumanthem Dhiraj Karan, MPS, DSP (Ops), and under the overall supervision of Shri AK. Sadananda Singh, Addl. SP TCP/IE and Shri Y. Joyraj Singh, Addl. SP (Ops) IE. At about 10:45 am, the combined team detained three persons from a rented house located at Mantripukhri Friends Colony. The individuals were identified as: 1. Khaidem Sunila Devi (55 yrs), W/o Ningthoujam Jigin Singh of Mayang Imphal Thana Wangkhei Leikai, 2. Laishram Thadoi (16 yrs), D/o Laishram Ibungo Singh of Wangjing Wangkhei, 3. Rezina Naorem (18 yrs), D/o (L) Naorem Romio of Wangjing Awang Leikai. During the examination, Khaidem Sunila Devi disclosed that she had harboured the two ladies on the false pretext of job opportunities for recruiting them into the UG group NRFM. She joined the said outfit, an organization under one Nao @ Tomthin in the year 2024 and presently working under SS Finance Sec. NRFM Tomthin. From her possession, one mobile handset (Redmi) bearing the mobile no. 7085378338, IMEI-1: 867555050546378 and IMEI-2: 867555050546386 were recovered and seized from her possession at 11:00 am. After verification, the two ladies were handed over to their families after due formalities. Accordingly, Khaidem Sunila Devi was placed under arrest at 11:05 am. The arrestee, along with the seizure, is hereby handed over to your kind authority for taking up necessary action as per law. Hence the case.
