One Jem. N. Nunghsibabu Singh, JC no. 916 of 7th IRB Now attached with CDO/IE Unit lodge a written report to OC HNG-PS stating that today i.e 30th September, 2025 at about 2:00 p.m. received a reliable information from our own source about the presence of some active members of the outfit UPPK at Mongjam Village and its surrounding area of Imphal-East District, who were involved in the extortion and wrongful detention of persons. Based on the said information and with the permission/authorization of the authority, a combined team of CDO/IE Unit along with teams of M & N Sector QAT, CRPF and Range Imphal QAT, CRPF conducted a C.I. Ops. at the said area under the command of Shri. Khumanthem Dhiraj Karan, MPS, Dy. SP(Ops)IE also looking after the charge of OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)IE at 3:00 p.m. In that, two unknown suspicious persons were detained for spot verification and checking at the foothill of Mongjam village near Community Hall, Imphal East District. On checking the detainees, one mobile phone and one wallet were found and recovered from their possession. On spot verification, the detainees identified themselves as; (i) Ngangbam Nishan Meitei @ Tamngakpa (24 years) S/o - Ng. Sarat Meitei of Khumbong Mayai Leikai, Patsoi PS, Imphal West District and (ii) Thongam Pariton Singh @ Ingba (38 years) S/o (Late) Th. Ibotombi Singh of Koirengei Thongkhong, Imphal East. On verification of the first detainee (Ngangbam Nishan Meitei), he stated that he is an active member of the outfit UPPK, joined through one Mr. Gerge of UPPK in the month of October, 2024 and got his basic military training for three months in the same year at Kakching Khunou, Kakching District, Manipur under the command of one s/s - Corporal Mr. Kakchinglakpa. On verification of the second detainee, (Thongam Pariton Singh) he stated that he is also an active member of the outfit UPPK, joined through one s/s - Second Lieutenant Mr. Moirangcha @ Lion @ Shamu @ Cheinangakpa of UPPK in the month of November, 2024. Both the detainees further stated that they are presently working under the command of the said s/s - Second Lieutenant Mr. Moirangcha @ Lion @ Shamu @ Cheinangakpa of UPPK. So, both the detainees were arrested from the spot i.e. foothill of Mongjam village near Community Hall, Heingang PS, Imphal East at 3:20 p.m. by observing due formalities. From the possession of the arrestee, Ngangbam Nishan Meitei, one mobile phone (TA-1578) bearing IMEI no. 359574379022917 along with one Airtel SIM card having phone no. 9362274924 was seized at the spot i.e. foothill of Mongjam village near Community Hall, Heingang PS, Imphal East at 3:25 p.m. by observing due formalities. One wallet containing one AAHAR Card and a sum of Rs. 40/- (forty rupees) was seized from the possession of the arrestee, Thongam Pariton Singh, at the spot i.e. foothill of Mongjam village near Community Hall, Heingang PS, Imphal East at 3:30 p.m. by observing due formalities. Hence the case.

Both the detainees further stated that they are presently working under the command of the said s/s - Second Lieutenant Mr. Moirangcha @ Lion @ Shamu @ Cheinangakpa of UPPK.

So, both the detainees were arrested from the spot i.e. foothill of Mongjam village near Community Hall, Heingang PS, Imphal East at 3:20 p.m. by observing due formalities. From the possession of the arrestee, Ngangbam Nishan Meitei, **one mobile phone (TA-1578) bearing IMEI no. 359574379022917 along with one Airtel SIM card having phone no. 9362274924** was

seized at the spot i.e. foothill of Mongjam village near Community Hall, Heingang PS, Imphal East at 3:25 p.m. by observing due formalities. **One wallet containing one AAHAR Card and a sum of Rs. 40/- (forty rupees)** was seized from the possession of the arrestee, Thongam Pariton Singh, at the spot i.e. foothill of Mongjam village near Community Hall, Heingang PS, Imphal East at 3:30 p.m. by observing due formalities.

Therefore, the arrested persons along with the seized items are being handed over to you for taking up further necessary legal actions against them.
