12. First Information contents:

I have the honour to state that today i.e. 29/03/2025 at about 11:05 am, a reliable information was received regarding the presence of some persons who were involved in selling SIM cards illegally in and around Khurkhul area of Imphal West District. Acting on the information, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW assisted by Subedar Ch. Surjitkumar and myself under the command of Shri P. Achouba Meetei, MPS, DSP(CDO)/IW, under the supervision of Shri M. Amit Singh, Addl. SP(Ops.)/IW and overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted cordon and search operation at Mandop Yumpham Relief Camp, Khurkhul. During the search, one unknown person was found in a very suspicious manner in the said relief camp. Due to his suspicious nature, he was detained at the spot for verification and checking.

During spot verification, he identified himself as Wahengbam Ajit Meetei (32 yrs.) @ Apa S/o. W. Tomba Meetei of Leimakhong Chingmang, Imphal West District a/p Mandop Yumpham Relief Camp, Khurkhul.

During preliminary verification, he disclosed that he has been selling SIM cards illegally at different areas of Sekmai, Khurkhul, Phumlou and Leimakhong. He further disclosed that he used credentials of the following persons (who are presently staying at the said camp) for SIM card activation and sold it to other persons without the consent/knowledge of the persons from whom the credentials were taken namely (i) Oinam Sunil of Leimakhong Bazar, (ii) Ngangbam Paleibi of Leimakhong Chingmang, (iii) Thokchom Inaobi of Leimakhong Chingmang, (iv) Wahengbam Raza

of Leimakhong Chingmang, (v) Wahengbam Bina of Leimakhong Chingmang, (vi) Khaidem Aboi of Leimakhong Chingmang and (vii) Khaidem Bijay of Leimakhong Chingmang. Further, he disclosed that the said SIM cards are sold to anti-social elements at high price and are suspected to be used by them for various illegal activities like extortion.

As pointed out by him, the following SIM cards were recovered from his room located at Mandop Yumpham Relief Camp, Khurkhul at his instance: (1) 22 nos. of BSNL 5G READY SIM cards, (2) 51 nos. of Airtel 5G Plus SIM cards and (3) 44 nos. of Airtel 5G Plus MNP SIM cards.

On spot checking, the following articles were recovered from his possession:

- 1) One Samsung Galaxy A33 5G mobile handset along with two SIM cards: (a) one Airtel SIM card bearing mobile no. 9612338368 (as disclosed by him) and (b) one Jio SIM card bearing mobile no. 7005079847 (as disclosed by him) and
- 2) One Aadhaar card bearing no. 9928 2904 9712.

Hence, he was arrested from the spot at 12:35 pm whereas seizure of the above recovered articles could not be done at the spot due to a mob consisting of Women folks and local youths who were obstructing the police team. Accordingly, a team of Sekmai-PS also arrived at the spot for mob control (which refers to GD Entry No. 21/Sek-PS/2025 dated 29/03/2025).

By considering the prevailing law and order situation and sensitiveness of the above mentioned spot, the arrested person and the above recovered articles were taken to CDO-IW Office Complex, Minuthong for further proceeding of seizure procedures and hence, the above recovered articles were seized at CDO-IW Office Complex, Minuthong at 02:06 pm by observing formalities.


