12. First Information contents:

I have the honour to state that today i.e. 03/04/2025 at about 02:00 pm, a reliable information was received from our own sources about the presence of some active cadres of KYKL organisation in and around Awang Potsangbam area with a view to commit prejudicial activities like extortion of money from the general public and shops etc. Acting on the information, a combine team of a column of 33AR and teams of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri P. Achouba Meetei, MPS, DSP(CDO)/IW under the supervision of Shri M. Amit Singh, Addl. SP(Ops.)/IW and under the overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted cordon and search operation at Awang Potsangbam Khullen Makha Leikai area in which outer cordon of the said area was done by the said column of 33 AR. During search at the house of one Sanabam Suren Singh located at Awang Potsangbam Khullen Makha Leikai, Imphal West District, one person was found in a very suspicious manner. Due to his suspicious nature, he was detained at the spot for verification and checking.

During spot verification, he identified himself as Maibam Naocha Singh (37 yrs.) S/o. M. Ibocha Singh of Awang Sekmai Khunou Makha, Imphal West District.

During preliminary verification, he disclosed that he is an active member of KYKL organisation and started working for the said organisation since March, 2024 and presently working under the command of two commanders namely (i) one s/s Commander Potsangbam Ibomcha @ Luckyson from Awang Potsangbam and (ii) one s/s Lieutenant Meira (Education Task Force) of KYKL organisation who is presently staying at Heirok and under the instruction of his commanders, he served monetary demands/threat to teachers of various colleges located in and around Imphal area since December, 2024 by using: (i) one Redmi mobile handset

along with one Airtel SIM card which was provided to him by his commander Lieutenant Meira in December, 2024 and (ii) one Honda Activa scooter red in colour. He further disclosed that he threw the said mobile handset into a plastic water drum located at the kitchen of the said house on seeing the police team.

As pointed out by him, the above mentioned Redmi 5G mobile handset bearing IMEI nos. (i) 862046066776220 and (ii) 862046066776238 along with one Airtel SIM card bearing SIM card number 8991160990026689088U was recovered from a plastic water drum located at the kitchen of the said house from his instance.

Again, as pointed by him, the above mentioned Honda Activa 125 scooter Rebel Red Metallic 2 in colour bearing registration number MN06SH 5536 along with its registration card and its key was recovered from the garage of the said house at his instance.

On spot checking, the following articles were recovered from his possession:

- 1) One Redmi Note 12 Pro+ 5G mobile handset along with two Airtel SIM cards bearing mobile nos. (a) 8974692527 and (b) 6909922207 (as disclosed by him)
- 2) One black wallet containing a sum of Rs. 2,400/- (Rupees two thousand and four hundred only) and one Aadhaar card bearing no. 5101 6249 2529
- 3) One Airtel SIM card bearing SIM card number 8991160990021549115U and
- 4) One Jio SIM card bearing SIM card number 89918650400118171703.

Hence, he was arrested from the spot at 03:27 pm and the above recovered articles were seized from the spot at 03:35 pm by observing formalities.
