Subject: - Report.

Sir,

I have the honour to state that today i.e. 03/10/2025 at about 12:05 pm, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of KCP (PWG) organization (a faction of KCP organization), an outlawed banned organization, in and around Naoremthong area of Imphal West District with a view to commit prejudicial activities like extortion of money from the shops and general public etc. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri K. Dinesh Kumar Singh, MPS, Dy. SP (CDO), IW and under the supervision of Shri. Gaurav Dogra, IPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Naoremthong area. During that one suspected person was detained at Chingangbam Leirak near Naoremthong Ball Lampak. During spot verification, the detainee identified himself as Athokpam Ranjan (28 yrs.) S/o. (L) A. Rajeshwar of Naoremthong Khulem Leikai, Imphal West District, Manipur.

During preliminary verification, he disclosed that he is an active member of KCP (PWG) organization (a faction of KCP organization) and started working for the said organization through one Maiken of KCP (PWG) organization since September, 2025. He also disclosed that he is presently working under the command of above-mentioned s/s Commander Maiken (Ph. Nos. 8414811248/ 9863554198) (Finance) of KCP (PWG) organization who is presently staying in Nepal. He further disclosed that under the instruction of his commander, he and his associate namely one Sanatomba (Ph. Nos. 8798803530/ 8259885639) of KCP (PWG) organization from Langthabal area were involved in extortion activities by serving monetary demands/threats to general public in valley area in connection with illegal settlement/mediation of crime against women cases between parties through intimidation for raising their party fund.

Hence, he was arrested from the spot i.e., at Chingangbam Leirak near Naoremthong Ball Lampak at 01:32 pm by observing formalities.

Further, from his possession, one OPPO A17 mobile handset along with one Jio SIM card bearing mobile no. 7005515346 (as disclosed by him) was seized at the spot at 01:38 pm by observing due formalities.

Hence, the arrested person and the seized article are handed over to you for taking further necessary legal action against him.
