Subject: - Report.

Sir,

I have the honour to state that today i.e. 03/10/2025 at about 01:25 pm, a reliable information was received regarding the presence of some active cadres of RPF/PLA organization, an outlawed banned organization, in and around Chingmeirong Mamang Leikai area under Lamphel PS with a view to commit prejudicial activities like extortion of money from the shops and general public etc. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri K. Dineshkumar Singh, MPS, Dy. SP (CDO), IW and under the supervision of Shri. Gaurav Dogra, IPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Chingmeirong Mamang Leikai area. During that two suspected persons along with one Maruti Celerio car white in colour were detained at Chingmeirong Mamang Leikai. During spot verification, the detainees identified themselves as (i) Thangjam Abung Meetei (31 yrs.) S/o. Th. Nando Meetei of Leirongthel Pitra, Thoubal District, Manipur a/p Wangkhei Ningthem Pukhri Mapal, Imphal East District, Manipur (owner of the above mentioned car) and (ii) Naorem Priyobarta Singh (27 yrs.) @ Tamo S/o. N. Purnima Singh of Kakching Wairi Sabal Leikai, Kakching District, Manipur.

From the possession of Thangjam Abung Meetei, (i) one Samsung Galaxy S22 mobile handset along with one Airtel SIM card bearing mobile no. 7085550924 (as disclosed by him), (ii) one Redmi Note 13 5G mobile handset along with one Airtel SIM card bearing mobile no. 8132865536 (as disclosed by him), (iii) one black side bag containing: (a) one .45 GLOCK pistol bearing no. ADAL048 along with one magazine loaded with 11 (eleven) rounds of .45 ammunition, (b) one Arm Licence bearing no. LN: 22420A7A3C222 and (c) a sum of Rs. 1,26,500/- (Rupees one lakh twenty six thousand and five hundred only), (iv) one black wallet containing one Aadhaar card bearing no. 5671 5204 7707 and (v) one Maruti Celerio car white in colour bearing registration number MN06LB 4807 along with its key were recovered.

From the possession of Naorem Priyobarta Singh, (i) one Samsung Galaxy A16 5G mobile handset along with one Airtel SIM card bearing mobile no. 8132987085 (as disclosed by him) and (ii) one black wallet containing a sum of Rs. 400/- (Rupees four hundred only) and one Aadhaar card bearing no. 3401 5327 0777 were recovered.

During preliminary verification, they disclosed that they are the active members of RPF/PLA organization and they are presently working under the command of one s/s Commander Manu Luwang (Ph. No. 8974561801) of RPF/PLA organization. They also disclosed that under the instruction of the commander Manu Luwang, they were involved in extortion activities by serving monetary demands/threats to general public in valley area in connection with illegal settlement/mediation of loan recovery cases between parties through intimidation for raising their party fund.

Hence, Thangjam Abung Meetei and Naorem Priyobarta Singh were arrested from the spot i.e., Chingmeirong Mamang Leikai at 03:40 pm and 03:44 pm and the above recovered articles were seized at 03:49 pm and 03:52 pm respectively by observing due formalities.

Hence, the arrested persons and the seized articles are handed over to you for taking further necessary legal action against them.
