Subject: - Report.

Sir,

I have the honour to state that today i.e. 05/10/2025 at about 11:05 am, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of KCP (PWG) organization (a faction of KCP organization), an

outlawed banned organization, in and around Naoremthong area of Imphal West District with a view to commit prejudicial activities like extortion of money from the shops and general public etc. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri K. Dineshkumar Singh, MPS, Dy. SP (CDO), IW and under the supervision of Shri. Gaurav Dogra, IPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Naoremthong Laishram Leirak area. During that one suspected person was detained from a house located at Naoremthong Laishram Leirak. During spot verification, the detainee identified himself as Rajkumar Sanathoi Singh (18 yrs.) S/o. RK. Dhaneshwor Singh of Naoremthong Laishram Leirak, Imphal West District, Manipur (who later identified himself as the resident of the said house).

During preliminary verification, he disclosed that he is an active member of KCP (PWG) organization (a faction of KCP organization) and started working for the said organization through one Suraj @ Bole of KCP (PWG) organization since June, 2023. He also disclosed that he is presently working under the command of one s/s Commander Maiken @ Malem (Ph. Nos. 8414811248) of KCP (PWG) organization. He further disclosed that under the instruction of his commander, he was involved in extortion activities by serving monetary demands/threats to shops, business establishments and general public in valley area and also involved in illegal settlement of cases related to crime against women for raising their party fund. Further, he also disclosed that he kept concealed one .32 pistol at his residence (at the storage compartment of his bed) which was handed over to him by one Chalamba @ Amujao @ Athouba of KCP (PWG) organization to be used in their party activities.

And the said one .32 pistol marked with "MADE IN NOKLAK NO 845 - 1" along with one magazine was recovered from his bedroom (from the storage compartment of his bed) at his instance.

Hence, he was arrested from the spot i.e., from his residence at 12:18 pm by observing formalities.

Further, from his possession/instance, (i) the above recovered .32 pistol along with one magazine and (ii) one Redmi 9 mobile handset along with one Airtel SIM card bearing mobile no. 8798803530 (as disclosed by him) were seized at the spot at 12:23 pm by observing due formalities.

Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.
