Subject: - Report.

Sir,

I have the honour to state that today i.e. 06/10/2025 at about 06:25 am, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of RPF/PLA organization, an outlawed banned organization, in and around Lamphel Supermarket area under Lamphel PS with a view to commit prejudicial activities like extortion of money from the shops and general public etc. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri K. Dineshkumar Singh, MPS, Dy. SP (CDO), IW and under the supervision of Shri. Gaurav Dogra, IPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Lamphel Supermarket area. During that one suspected person was detained at Lamphel Supermarket. During spot verification, the detainee identified himself as Ashem Robindro Meitei (38 yrs.) @ Rock @ Sathiba S/o. (L) A. Mohonsing Meitei of Napat Awang Leikai, Bishnupur District, Manipur a/p Lamphel Supermarket, Imphal West District, Manipur. During preliminary verification, he disclosed that he is an active cadre of RPF/PLA organization and joined the said organization in March, 2000 through one s/s Corporal Kumar of RPF/PLA organization from Heirok area and got Basic Military Training for 45 days in Singhat, Churachandpur District and was allotted Army No. 2019 and he is presently holding the rank of s/s Lance Corporal of RPF/PLA organization. He also disclosed that he is presently working under the command of one s/s Major Ronel (Ph. No. 8798619966) of RPF/PLA organization who is presently staying in Myanmar. He further disclosed that under the instruction of his commander, he was involved in organising their party activities by hoisting/unfurling/transporting flags and banners of RPF/PLA organization from Wangoo to Sugnu area in connection with the raising day celebration of RPF/PLA organization on 25/09/2025.

Hence, he was arrested from the spot i.e., Lamphel Supermarket at 08:46 am by observing formalities. Further, from his possession, (i) one OPPO A58 mobile handset along with two SIM cards i.e., (a) one Jio SIM card bearing mobile no. 9863744059 (as disclosed by him) and (b) one Airtel SIM card bearing mobile no. 9233658467 (as disclosed by him), (ii) one Aadhaar card bearing no. 6088 5367 5715 and (iii) one Inmate Identity card bearing ID No. 115 issued by Convenor In-Charge Sugnu Relief Camp Guest House KCG. - 3-052 were seized at the spot at 08:52 am by observing due formalities. Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.
