

Subject: - Report.

Sir,

I have the honour to state that today i.e. 13/10/2025 at about 06:05 pm, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of KCP(Apunba) organization (a faction of KCP organization)- an outlawed banned organization, in and around Lamphel Super Market area of Imphal West District with a view to commit prejudicial activities like extortion of money from the shops and general public etc. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri. P. Achouba Meetei, MPS, Dy.SP(CDO)IW and under the supervision of Shri. Gaurav Dogra, IPS, Addl. SP(Ops.)IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Lamphel Super Market area. During that one suspected person along with one TVS Jupiter Scooter white in colour was detained at Lamphel Super Market. During spot verification, the detainee identified himself as Haobam Malemnganba Singh (25 yrs.) @ KGF S/o. H. Imo Singh of Lalambung Makhong Takhellambam Leikai, Imphal West District, Manipur.

During preliminary verification, he disclosed that he is an active member of KCP(Apunba) organization (a faction of KCP organization) and started working for the said organization since December, 2024. He also disclosed that he is presently working under the command of one s/s Commander Angamba of KCP(Apunba) organization from Singjamei area who is presently in Bangladesh. He further disclosed that under the instruction of his commander Angamba, he was involved in extortion activities by serving monetary demands/threats to general public in valley area for raising their party fund.

Hence, he was arrested from the spot i.e., at Lamphel Super Market at 07:48 pm by observing formalities.

Further, from his possession, (i) one vivo 1811 mobile handset along with two Jio SIM cards bearing mobile nos. (a) 6009890415 and (b) 7005779616 (as disclosed by him) and (ii) one TVS Jupiter Scooter white in colour bearing registration no. MN01U 1711 along with its key were seized at the spot at 07:55 pm by observing due formalities.

Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.
