That, on 20/10/2025 at about 6.30 pm, one person namely Pongsumbam Pahari Singh, aged about 48 yrs S/o Late P. Leibakmacha of Iroishemba opposite Club, Imphal West had come at my daughter's Ibemcha Banana Godown located at Lamboikhongnangkhang, Lane No. 7 and meet my daughter-in-law namely Laishram Ongbi Razia and Niece Sorokhaibam Meneka Devi (21) yrs. Later Pongsumbam Pahari enquired about my daughter namely Laishram Ibemcha, aged about 38 yrs D/o Late. L. Dhaneshor of Kangchup Sanjenbam to them. At the same time, Laishram Ibemcha came at the Godown and meets him. Suddenly, the said Pahari had assaulted her by strangulating as well as by punching at her head with an intension. As a result of the assault, my daughter Laishram Ibemcha Devi received pained at her neck and head.

Therefore, I request you to kindly take necessary action against Pahari for his wild act.
