Sir,

I have the honour to state that today i.e. 29/10/2025 at about 05:05 am, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR and around Langol Game Village area with a view to commit prejudicial activities like extortion of money from the shops, general public and recruiting members etc. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW assisted by W/Inspector Sh. Sarjubala Devi of CDO-IW and myself under the command of Shri P. Achouba Meetei, MP5, Dy. SP (CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Langol Game Village Zone-I area. During that one suspected woman was detained at a Quarter bearing number B-353 located at Langol Game Village Zone-I. During spot verification, the detainee identified herself as Ningthoujam Anita Devi (44 yrs.) @ Rashida w/o. Tekcham Basanta Singh of Sairemkhui Maning Leikai, Imphal West District, Manipur a/p Langol Game Village Zone-I, Quarter No. B-353, Imphal West District, Manipur.

During preliminary verification, she disclosed that she is an active cadre of RPF/PLA organization and joined the said organization in the year 1999 through one Rashithoi of RPF/PLA organization from Sawombung area and got Basic Military Training for 45 days at GHQ near Burma border area and was allotted Army No. (unable to remember). She also disclosed that she is presently working under the command of one s/s Commander Sunil of RPF/PLA organization from Jiribam area. She further disclosed that under the instruction of her commander, she was involved in recruiting a girl of Jiribam District for their proscribed party. Later on, the said girl was handed over to her commander around one month back, at Lamphel area.

Hence, she was arrested from the spot i.e., Quarter bearing number B-353 located at Langol Game Village Zone-I at 06:37 am by observing formalities.

Further, from her possession, (i) one Redmi 14C 5G mobile handset along with one Airtel SIM card bearing mobile no. 7085113701 (as disclosed by her) and (ii) one Aadhaar card bearing No. 6076 3864 8383 were seized at the spot at 06:43 am by observing due formalities.

Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against her.
