Sir,

I am to report today i.e. 01/11/2025 at 1.30 am, received a reliable input from 33AR corroborated with own source regarding about the movement of some armed miscreants at Kwakeithel Mayai Koibi area. Based on the input, immediately, a combined team of CDO-BPR led by self and assisted by civil teams of CDO-BPR commanded by Inspt. Y. Motilal Singh, OC-CDO/BPR under the supervision of Shri Chaitanya, IPS, Addl. SP(Ops)/BPR and under the overall guidance of Shri Th. Shangkar Deba, MPS, SP-Bishnupur rushed to the said area and conducted search of the suspected persons at Kwakeithel Mayai Koibi Ningthoujam Leikai after giving prior information to the concern authority.

During the course of search, one unknown person was found at a house located at Mayai Koibi Ningthoujam leikai in a suspicious nature. On spot verification, the unknown person identified himself as Pebam Nikesh @ Nanao @ Mitlang @ Poirei (28) years S/o P. Ranjit Singh of Kwakeithel Mayai Koibi Ningthoujam Leikai. On questioning, he disclosed that, he is an active cadre of PREPAK joined in the month of November, 2023 through one Bira of PREPAK. He got BMT for 45 days at Karang, Bishnupur District and worked under the command of one Prem of PREPAK. So, he was arrested from the spot at 3.21 am. On body search, found 1. one redmi note 7 pro mobile phone blue in colour with two SIM i) 6009976682 (JIO) & ii) 8257887017(vodafone-VI) 2. one PAN card standing in the name of Pebam Nikesh bearing card no. CCPPN8981G and 3. one Aadhaar card bearing no. 371435139110 and the same was seized at 3.27 am from his possession by observing proper formalities.

Hence, the arrested person along with the seized item are handed over to you for taking further necessary legal action against him.


