Subject: FIR seeking justice and appropriate action against Shri Chonghor Debbarma and others for rape, cheating, criminal intimidation, and exploitation.

Madam,

With due respect to the above-referred subject. I. Smt. Amy Debbarma (26) D/o Manuj Kr. Debbarma, R/o Ramhari Para Golaghati, presently residing at Nandan Nagar Khakchang Complex, West Tripura, Agartala, Pin- 799006, beg to submit the following facts before your kind office seeking justice and appropriate legal action against Shri Chonghor Debbarma, S/o Umesh Debbarma, R/o Bidhya Chandra Para, Paschim Jirania Khala, PS Radhapur, PO- Birendra Nagar, Pin-799045 and others involved in the matter.

That in the end of 2021, I came in contact with Mr. Chonghor Debbarma through a mutual friend. We became friends, and gradually our friendship developed into a love affair. On several occasions, he requested me to visit Manipur where he was pursuing his BDS (Bachelor of Dental Surgery) course at RIMS Manipur.

Thereafter on his repeated requests, in the month of February 2022, I went to Manipur to meet him and stayed there for a few days. During that stay, one night while I was asleep, he suddenly tried to get physically intimate with me. I resisted and tried to stop him, but he forcibly established physical relations with me against my will. When I started crying, he consoled me saying that he truly loved me and would marry me soon. I trusted him and did not report the matter out of fear and emotional pressure. Thereafter, in the month of February 2023, he took me to his native village and introduced me to his parents. His parents accepted me and I stayed in their house for a few days. During that period, in the absence of his parents, he again forcibly got physically intimate with me, stating that, since I had already been introduced to his family, we would be getting married soon. Subsequently, on March 2023, I went back to Manipur and we stayed together there in a live-in relationship. During that period, his younger brother also used to stay with us. He continued to have sexual relations with me repeatedly under the false promise of marriage. That in 2023, due to the violence that took place in Manipur, we returned to Tripura. After returning, he frequently visited my house, stayed for a few days, and then left. During this period, he began demanding money from me frequently, citing reasons such as credit card bills and personal expenses. Out of love and trust, I provided him total amount of Rs. 5,00,000 (Rupees Five Lakh), through bank transfer, UPI, and cash on different occasions. I also took a loan to help him financially. Accordingly, I purchased an iPhone 14, as his birthday gift on EM in his father's name, though I have been paying all EMIs myself. I have all the payment records and can furnish them whenever required. I also spent money on his shopping, food and personal requirements. Wherever I refused to give him money, he would get angry, behave rudely, and emotionally blackmail me, saying that I didn't understand or love him. That, since, both our families were aware of our relationship, our parents met and decided to formalize the same. Accordingly, on 4th November 2024, our engagement ceremony was held at AWJA Restaurant, Lembucherra, in the presence of our families, relatives, and friends. Thereafter in January 2025, he went back to Manipur for his studies. Soon after, I found out that I was pregnant with his child. When I informed him about it, he asked me to come to Manipur and stay with him. In February 2025, I went to Manipur and stayed with him in a rented room. During that time, he again demanded Rs. 10,00,000/- (Rupees Ten Lakh). When I expressed my inability to provide the money due to my father's financial difficulties, he verbally and physically assaulted and tortured me, even while I was pregnant, due to which I got severe injuries, and for this reason, I had to avail Medical treatment, in Manipur. I still have the Medical Reports with me. He also threatened me that, unless I fulfilled his monetary demand, he would not marry me. Upon learning about my pregnancy, my parents approached his parents multiple times to fix our marriage. However, they ignored the matter and gave excuses, citing financial problems and his on-going studies. They also pressurised me to abort my child, saying, that we could have another baby later after the marriage. I refused to do so, and firmly stated that, I would never abort my child. Thereafter, in May 2025, I returned to Tripura as my delivery date was approaching and my parents called me home for proper care. Subsequently, I came to know that my fiancé had taken another woman, Ms. Gishika Debbarma, D/o Lt. Faguna Debbarma, R/o- Bara Janira, PS Baijalbari, PO- Ratanpur Khowai Tripura, to our rented room in Manipur for which I was paying rent. When I confronted him about it, he initially denied the allegation, but upon being shown proof he admitted his affair and sought forgiveness. Out of love and for my unborn child's future, I forgave him at that time. That on 31st August 2025, I gave birth to my child at Unity Hospital, Agartala. Even then, he was reluctant to visit me and the baby, I had to book his flight ticket and bear all expenses just to bring him to the hospital. He stayed briefly and left soon after. Subsequently, on 15th September 2025, when my baby fell ill and was admitted to GBP Hospital, Agartala, he again demanded Rs. 10,00,000/- (Rupees Ten Lakh), stating that unless I paid him, he would not accept me or the child. When my parents informed his parents, they supported his demand, saying that the money was for our future and to help him open a dental clinic.

Later, it came to my knowledge that, he continued his illicit relationship with Ms. Gishika Debbarma. After that I had managed to collect mobile phone number of Miss Gishika Debbarma and informed her a got now details regarding relation with my husband Sri Chaonhar Debbarma and even also intimated her a got now born child. But she arrogantly stated that, they are going to marry soon. She further said that, my fiance would not return to me because she was "better" than me, being a Government employee, Khowai Tripura, and that words, "just an ordinary girl". She is currently serving as LDC at Padnabil Block, Khowai Tripura, and that time my fiance was carelessly telling me not to make scene. Shocked by her statement, I asked how she could be so heartless as a woman, knowing that she was destroying another woman's life. Upon hearing this, she became very aggressive and furious and through mobile phone abused me using obscene and derogatory language. Thereafter, I informed my parents about the matter. My parents tried to contact the parents of my fiancé to resolve the matter amicably. Initially, his parents requested some time to "resolve the issue" but later they blocked all communication with us and did not take any step to address the situation. On 09/10/2025, my parents again approached his parents to discuss the matter, but they behaved in a very disrespectful manner and stated that since we were unable to fulfil their unlawful demand of Rs 10.00.000/- and were not providing financial support to their son, we should leave him alone. They then abruptly disconnected the call. Subsequently my parents made several attempts to contact them over the phone, but they neither received the calls nor called back. Till date, I have given him a total of Rs. 5,00,000/- (Rupees Five Lakh) and also paid monthly rent of Rs 8.000/- for his accommodation in Manipur from January 2025 to September 2025. Even at present my ATM card also into possession of my husband Chonghar Debbarma which was given him for opportunity of money transaction and withdrawal purpose. In view of the above stated circumstances, I humbly request your good office to kindly register a case and take necessary legal action against Mr Chonghar Debbarma. His parents (names to be verified during investigation) and Ms. Gishika Debbarma, for committing offences punishable under the relevant sections of the Bharatiya Nyaya Sanhita, 2023 (BNS), including but not limited to Section 63. Section 64(2)(n), Section 69 Section 318 Section 316. Section 115. Section 75. Section 351 Section 77 Section 3(5) Acts done by several persons in furtherance of common intention and other applicable provisions of law for protection of women from exploitation and violence. I request your kind intervention to register my complaint as an FIR and take prompt and appropriate legal action against the accused persons to ensure justice for me and my child. I am ready to furnish all supporting evidence including money transfer proofs, EMI payment details, photographs of our engagement and medical documents as required during the investigation.
