Subject: Request for taking up legal action against the unknown culprits who trespassed into our residence.

Sir,

With due respect, I the undersigned have the honour to state the following few lines for your kind consideration and favorable action:

1. That, I am presently residing at the Quarters No. TA 72 of Langol Game Village Zone-III along with my husband namely, Ngashepam Rocky Singh and my mother with two minors.
2. That, on 25-11-2025 at around 12 in the midnight some unknown persons numbering about 10 in number who are masked and wearing camouflage dress came to my residence and other neighbouring quarters and they came inside the house and knocked at the door of my residence. My mother opened the door and some 5/6 persons armed with pistol and sophisticate heavy guns stormed inside the house and pulled out my husband who was sleeping at his bedroom and at the courtyard and started assaulting him by kicking and striking using the automatic guns on his head and face. He was injured grievously and evacuated to hospital and done treatment at RIMS, Lamphelpat [MLC-25/4961]. At the relevant time I was not at my Quarters as I was attending a patient (relative) at Shija Hospital.
3. That, some of the CCTV footage were also taken when the said unknown culprits trespassed my quarters and surrounding quarters. (Enclosed)
4. That, it is pertinent to mention that another incident has also happened to me on 04-08-2025. And a report was also made to the Superintendent, Imphal West and receipt No. 429 dated 09-08-2025. (Copy enclosed)

I therefore, supplicate your goodself to take up appropriate legal action against the unknown culprits and book them under stringent law.


