On 24/04/2025 at about 02:25 pm, a reliable information was received from 2/8 GR (Indian Army) and further corroborated from our own source regarding the presence of some active cadres of RPF/PLA organisation in and around Khonghampat area with a view to commit prejudicial activities like extortion of money from the general public, schools and shops etc. Based on the information, a combined team of a column of 2/8 GR (Indian Army) and a team of CDO-IW led by Subedar Ch. Surjit Kumar of CDO-IW and myself under the command of Shri. P. Achouba Meetei, MPS, Dy.SP(CDO)IW and under the supervision of Shri Gaurav Dogra, IPS, i/c Addl. SP(Ops.)/IW and under the overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted frisking and checking at Khonghampat near the Orchid Farm. During that one unknown person loitering near the Orchid Farm in a very suspicious manner was detained at the spot for verification and checking.

On spot verification, he identified himself as Phuritshabam Sunil Singh (39 yrs.) @ Negro @ Jackson s/o. (L) Ph. Shyamjai Singh of Leimakhong Chingmang, Imphal West District a/p Mandop Yumpham Relief Camp, Khurkhul.

On spot checking, one One Plus 7T mobile handset along with one Airtel SIM card bearing mobile no. 8731029498 (as disclosed by him) was recovered from his possession.

During preliminary verification, he disclosed that he is an active cadre of RPF/PLA organisation and joined the said organisation in the year 2008 through one Thoithoi of RPF/PLA organisation and got Basic Military Training for 45 days at Taka, Myanmar in the year 2008 and was allotted Army No. 3113 (of 2008 Batch). He further disclosed that he is presently holding the rank of s/s Corporal of the said organisation since the year 2012 and is presently working under the command of one s/s Major Irengba of RPF/PLA organisation since 2024. He also disclosed that under the instruction of his s/s Commander Irengba, he was engaged as a training instructor and gave basic military training for 15 days to 118 new recruits of RPF/PLA organisation at Chingnungkhok in the month of April, 2024.

Hence, he was arrested from the spot at 03:00 pm and the above recovered mobile handset was seized at the spot at 03:07 pm by observing formalities.

Hence, the arrested person and the seized article are handed over to you for taking further necessary legal action against him.


