Subject: Report on arrest of KCP (MFL) members involved in threat to Sangai Festival, 2025.

Sir,

In connection with a threat video uploaded on 21/11/2025 on Facebook by the user “Meitei Lanmi Naotyboy,” wherein a warning was issued to bomb the Sangai Festival 2025 (scheduled from 21–30 November 2025), an enquiry was initiated by Insp. Rajib, In-Charge, Technical Intelligence Unit, Imphal East District. During the course of the enquiry, several active members of the banned organisation KCP (MFL), operating in the Khongman–Okram Chuthek area and other adjoining districts, were identified.

Based on the said input and with due authorisation, a combined team of the Technical Intelligence Unit of Imphal East District, CDO/IE, assisted by ASI Md. Sabir Ahamed with woman police personnel, CDO/TBL, and a column of 31 Assam Rifles, launched a CI Operation at Okram Chuthek under the command of Inspector Anilchandra Mutum, OC/CDO-IE.

During the operation, one suspected woman was detained for spot verification. She identified herself as Laishram Sonia Devi (31 yrs) of Okram Chuthek and admitted to be an active member of KCP (MFL) since November 2024, working under s/s Sgt. Major Naotyboy and collecting money from the public on his instructions.

One Redmi 13C 5G mobile phone (IMEI: 861623066984748/55) with Airtel SIM 9233636631 was seized from her at 08:40 a.m. following legal formalities. She was brought to CDO/IE for further verification.

During examination, she revealed that one of her associates, Salam Luwangnganba Meetei @ Ibungo (22 yrs), was residing at Tera Sadokpam, Imphal West. A CDO/IE team, along with the detainee and after informing Imphal West Police, proceeded to the said location. On her pointing, Luwangnganba was apprehended. One Realme Narzo 50 Pro (IMEI: 861084053235331/30, 861084053235323/30) with Airtel SIM 9362098821 was seized from him at 02:40 p.m.

He disclosed that he joined KCP (MFL) through the same handler, Naotyboy, and was working under Phandom Phampok Meitei @ Ajay @ Abungcha (29 yrs) of Wangjing Bazar, Thoubal District. Acting promptly, the team moved to Wangjing Bazar along with the two detainees. On the pointing of the second detainee, Phandom Phampok was located at his residence. One Redmi Note 11T 5G (IMEI: 861083055750388/78, 861083055750396/78) with Airtel SIM 8415034501 and Jio SIM 6009538612 was seized from him at 02:35 p.m.

It is submitted that videography of seizure could only be completed for the first detainee. At the locations of the second and third detainees, large and hostile mobs gathered, attempting to

obstruct police action and forcibly take away the detainees, due to which videography could not be conducted.

During further examination at CDO/IE, Phamdom Phampok Meitei admitted that he joined KCP (MFL) in October 2024 through Naotyboy and is presently working under him. He further disclosed his involvement in a plan to hurl grenades at the ongoing Sangai Festival, 2025, and that he had been instructed to collect grenades from an individual at Nongpok Kakching, Imphal East.

Based on their disclosures, recovery of incriminating articles, and confirmation of their active membership in KCP (MFL) and their conspiracy to attack the Sangai Festival, the three accused persons were formally arrested at Commando Imphal East Unit, Porompat @ 04:30 p.m.

Hence, the arrested persons along with the seized articles are hereby handed over to your Police Station for taking up necessary legal action as per law.
