Subject: Report.

Sir,

I have the honour to report that today i.e., the 4th December, 2025 at about 1:10 p.m. received a reliable information from our own source corroborated with the intelligence of 33 AR about the presence of an active member of the outfit PREPAK, an alliance of G5, at Iriblung area of Imphal East District. Based on the said information and with the permission/authorization of the authority, teams of CDO/IE Unit conducted a C.I. Ops. at the said area under the command of Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 2:10 p.m.

In that, one unknown suspicious person was detained for spot verification and checking at Iriblung Kabui Khul, opposite to Master Sanky English School, Iriblung PS, Imphal East. On checking the detainee body, one mobile phone was found and recovered from his possession. On verification, the detainee identified himself as one, **Akojam Univers Meitei @ Lukhoi (27 years) S/o (Late) Akoijam Basanta Meitei of Bamon Kampu Mayai Leikai, Hiranpham Thong, Iribung PS, Imphal East District.** On verification, the detainee stated that he is an active member of the outfit PREPAK, an alliance of G5, joined through ones s/s - Commander Mr. Mukoiba @ Aku of PREPAK, an alliance of G5, in the month of September, 2025 and presently working under his command. The arrestee further stated that he is directly involved in recruiting new cadres to their outfit on the advice of the said Mr. Mukoiba @ Aku of PREPAK, an alliance of G5.

So, the detainee was arrested from the spot i.e. Iriblung Kabui Khul, opposite to Master Sanky English School, Iriblung PS, Imphal East at 2:40 p.m. and seized **one mobile phone (One plus Nord CE) bearing IMEI no. 869768054000171 & 869768054000163 along with one Airtel SIM Card having phone no. 9378022676** at the spot i.e. Iriblung Kabui Khul, opposite to Master Sanky English School, Iriblung PS, Imphal East at 2:45 p.m. by observing due formalities.

Therefore, the arrested person along with the seized mobile phone is being handed over to you for taking up further necessary legal actions against him.
