

Subject: Enquiry Report for Registration of FIR — Road Accident on 03/11/2025.

Ref: GD Entry No. 14/IBG-PS/2025 dated 04/12/2025

Sir,

As per endorsement, I conducted an enquiry on the written report submitted by Thongram Narjit (36 yrs), S/o Thongram Singhajit, Huikap Awang Leikai, regarding a self-accident involving a Tata Oil Tanker (Regd. No. MN 01 9222) on 03/11/2025 at approximately 7:00 pm at Keirao Wangkhem near Stone Crusher, Imphal–Ngariyan Road. The driver, Thongram Sheitam (47 yrs), S/o Thongram Singhajit (brother of the complainant), was driving from Andro towards Imphal. The tanker (Chassis No. MAT388344D1D03757, Engine No. B591303331D63320704), registered in the name of Nganbam Noro Singh of Leimakhong Bazar, skidded and fell on the southern side of the road, causing severe injuries to the driver. He was initially admitted to JNIMS Hospital and later referred to Shija Hospital, Langol. The tanker sustained major damage.

The enquiry revealed the following:

The accident site showed fresh tyre marks and vehicle position indicative of a self-accident. The tanker was found overturned on the southern roadside with visible cabin and body damage. Eyewitnesses confirmed the vehicle skidded and overturned independently, with no involvement of other vehicles. The driver is undergoing treatment at Shija Hospital, and his condition is reported as critical based on available information.

In light of the above findings, this is a clear case of self-accident, causing injuries and property damage.

As the incident is cognizable and involves injuries, it is recommended that a regular FIR be registered under appropriate sections of the Motor Vehicles Act for further investigation.
