First Information contents: Today i.e, 21/11/2025 A combine team comprising of Churachandpur District Police, including Sangaikot Police, RL-CCP, Women Police-CCP, 36 AR, NAB-CCP and DFO-CCP launched destruction of illegal poppy cultivation in D.Lhangjol Hill Range of Sangaikot Sub-Division, Churachandpur, The total area of illegal Poppy destruction is estimated to be 8 Acres (approx.), , the operation started at 10:30 AM and concluded at 01:30 Pm of the same day.

During the operation, no arrest was made as no cultivators were found and the land owner could not be identified as it is located in the interior region, However, some pods of poppy plants were seized from the area of destruction after observing proper formality.


