First Information contents: In continuation with the "war on drugs" a combined team comprising of Ukhrul district police ,18th AR and 6th MR led by inspt krili James ,OC SDL-PS under the supervision of SP/UKL, carried out intensive destruction drive against illegal poppy plantation from 11 to 15/11/2025 along the Kachai and Maichon village hill ranges, during the poppy destruction drives, an estimated areas of about 2 acres on 11/11/2025, 8 acres on 12/11/2025, 10 acres on 13/11/2025, 15 acres on 14/11/2025 and 19 acres on 15/11/2025, total of 54(fifty four) acres were destroyed which is expected to yield about 486(four hundred eighty six) kgs of opium(9 kgs per acres) no cultivators were found in the fields and no arrest was made during the destructions. seized some suspected poppy pods from the field for adducing evidence.

Hence, a regular case on sou-motu under FIR NO.01(11)2025 SDL-PS U/S 18(b)ND & PS ACT has been registered for investigation,endorsed to SI.M. Soreithing .
