



Subject: Report.

I am to state that on 22/11/2025 at about 09:15 am a combined team of District Police Chandel, under the supervision of SP/Chandel led by a team of Addl SP(OPs)-CDL, OC Chakpikarong Police Station, Chandel Police team, Reserve Line Chandel, 43 Assam Rifles, 17 Assam Rifles, 8 MR personnel, BSF E/200 Coy, Forest Department Chandel, NCB and NAB Police team, altogether 120 personnel destroyed about approximately 50 (Fifty) acres of illicit Poppy cultivation at Gobok hill range located about 20 km East from the Police Station under Khengjoi Sub-Division which could produce approximately 250 Kgs of poppy worth Rs. 17,500,000/- (Rupees one crore and seventy five lakhs). There was no one present at the spot except the destruction party moreover no one came forward to claim ownership of the poppy cultivation. As there was no one present in cultivation site, I requested two persons from the destruction party to stand as witnesses.

Then at the spot, in presence of the witnesses, I seized Poppy pods and poppy seed less than one Kg which was found concealed in the hut for identifications and put them separately inside plastic packets and inserted them inside three yellow envelopes which were properly packed and sealed by using wax and marked "A" (original sample) "B" (duplicate sample) and "C" (parent) exhibit respectively by observing all formalities.

Thereafter, all the destroyed poppy plants were eradicated by burning them down on the spot. Apart from that four temporary huts were also burnt down. Photographs were taken properly before and after the destruction for further reference. I also received Destruction Certificate from SDM Khengjoi as the place of occurrence falls under Khengjoi Sub-Division, Chakpikarong Police Station. I brought the seized articles and relevant documents at Chakpikarong Police Station and handed over the same to the Officer In-charge Chakpikarong Police Station for taking necessary legal action.
