Sir,

I am to report that on 26/07/2025 at around 3:30 AM, received an input from 19 AR corroborated with our own source regarding hideout of some arms and ammunitions suspected to be concealed by some unknown arm miscreants at the adjoining areas of Moirang Turel Mapal Kwakta Ward no. 9(KMC) and Phuisenphai village under the jurisdiction of PGCI-PS. Immediately a joint search operation was launched by a combined team of CDO/BPR led by self and assisted by SI M. Romen Singh, Jem. A Shanti Singh, a team of PGCI-PS led by Inspt. Nongthombam Samson Singh (OC/PGCI-PS) and one column each of 19 Assam Rifles led by Maj. Mayur Mehra, 19 Garhwal Rifles led by Sub. Udaypal Singh and D/71 Bn CRPF led by AC Jayan Viswanath. The operation was conducted under the command of Shri D. Robinson MPS, DSP (CDO-II)/BPR and Inspt. Y. Motilal Singh, OC/CDO-BPR under the supervision of Shri. Amarjit Singh Lamabam, Addl. SP (Ops), Bishnupur and under the overall guidance of Shri Ksh. Ravikumar Singh, IPS, SP- Bishnupur. During the operation, the following Arms cache were recovered:-
