

3. A team of PGCI-PS, led by ASI Md. Ziaul Haque under the overall command of Inspector Subhaschandra Konthoujam, OC/PGCI-PS

4. A column of 19 Garhwal Rifles, jointly conducted routine frisking and checking duties at Kwakta Bazar Naka Checkpoint. This operation was carried out in view of the upcoming Manipur State Legislative Assembly session and the prevailing law and order situation, under the supervision of Shri Lamabam Amarjit Singh, MPS, Addl. SP (Ops), Bishnupur and the overall supervision of Shri Ksh. Ravikumar Singh; IPS, Superintendent of Police, Bishnupur District, Manipur.

During the operation, a white Tata Yodha 1700 (Registration No. AS 26 C 8774) was seen approaching from Phouljang towards Kwakta Bazar. Upon noticing the security personnel checking vehicles, the driver attempted to evade inspection and proceeded towards Moirang along NH-02 (Tiddim Road). The security personnel immediately initiated a chase and intercepted the vehicle near Anita STD High School, Kwakta Pangal Lamkhai.

Upon investigation, the driver identified himself as Md. Tajuddin (29 years old), son of Md. Haider Hussain, resident of Lilong Litan Makhong, PO-Thoubal, PS-Lilong, Thoubal District, Manipur. Immediately, passersby were requested to witness the search of the vehicle.

In the presence of witnesses, a thorough search was conducted, leading to the discovery of two polythene-wrapped packets concealed in the back seat compartment. Upon interrogation, Md. Tajuddin revealed that the contraband items, suspected to be brown sugar, were brought from Churachandpur District, Manipur.

I then instructed a team member to bring a weighing machine from the police station and simultaneously informed and requested the Executive Magistrate (EM), Moirang over the phone to be present at the spot for the weighing and seizure of the suspected narcotics.

Upon the arrival of the Executive Magistrate, the suspected brown sugar was weighed and found to be:

- (i) 523 grams, marked as "A" (including the weight of the wrapped transparent white polythene)
- (ii) 518 grams, marked as "B" (including the weight of the wrapped transparent white polythene)

Total: 1041 grams (including the weight of the wrapped transparent white polythene).

The seized contraband was then placed inside a carton box, marked as "Z", which was properly packed and sealed.


