Later at about 6:20 pm, the gathered crowd started getting violent and security personnel deployed at the resorted forced to disperse the violent mob by firing several rounds of tear smoke. During the violent incident, the check post of PGCI PS was dismantled by the mob and started burning woods and other materials on the Highway. Due to continuous pelting of stone by the mob, some police
