\***First Information contents:** In accordance to SP/Ukhrul vide Order Memo No. C-1(G/P)/2025-SP(UKL)/11973 dated 08/11/2025, a joint team of District Police, Ukhrul, 6<sup>th</sup> Bn. Manipur Rifles, 18<sup>th</sup> Assam Rifles and District Forest Department, Ukhrul launched an extensive poppy destruction operation w.e.f. 11/11/2025 to 15/11/2025 at the hill range covering Phalee, Teinem, Champhung & Tora villages, after the Magistrate on duty furnished Attachment Order and Destruction Order of illicit poppy cultivation in the said area U/S 18(b) ND & PS Act, 1985 (as amended). In the 5-day long operation, the combined team successfully destroyed about 140 (one hundred forty) acres of poppy cultivation in the said area. It is expected to yield 1400 (One thousand four hundred) Kg approx. (10 Kg per acre) of opium from the destroyed cultivation area. So far, none of the illicit cultivators could be individually identified. Thus, seized some poppy pods and poppy plants for examination and for inducing them into evidence.

Hence, a Suo- Moto case under **FIR No. 03(11)2025/LM-PS, U/s 18(b) ND & PS Act** was registered and endorsed to ASI. CL. Mathew for investigation.
