Today, i.e., 02/12/2025, at around 9:15 AM, an information was received that on the same day at about 9:05 AM, one Honda Activa (registration number not known) ridden by an unknown rider coming from Thoubal side towards Yairipok side and another Honda Activa (registration number not known) ridden by an unknown rider coming from the same direction collided with each other at Yairipok Siphai Leikai near Masjid along Yairipok-Thoubal road, due to rash and negligent riding on the part of the said unknown riders of the vehicles. As a result, the unknown female pillion rider of one of the Honda Activa sustained injuries and was


