

**Subject :** - Request to give direction to the Officer-in-Charge, Yairipok Police Station to take up necessary legal actions against the undernoted culprits.

Sir,



With due respect, we, the undersigned Applicants No. 1 and 2 would like to submit the following few lines for your kind consideration and necessary affirmative action.

1. That, the undersigned Applicants No. 1 and 2 are residents of Pechi Makha Leikai, P.S. Yairipok, District- Thoubal. The Applicant No. 1 is the uncle of Applicant No. 2.

2. That, on 26-11-2025, at around 11:40 A.M., the Applicant No. 1 orally made a complaint to the Secretary of his village to give a direction to the concerned to clean the mud which were brought from the paddy fields from the beginning of his Leirak i.e. Pechi Makha Leikai Yumnam Mapa upto Haobam Leika as there were so many mud on the Road. Thereafter, the village's Secretary of Applicants told the persons who were responsible for the same namely, (1) Nongthombam Selung Singh, S/o (Late) Nongthombam Birmani Singh of Pechi Awang Leikai who is driver of a Tractor and (2) Abujam Bhogendro Singh, S/o Abujam Nimaichand Singh of Pechi Makha Leikai who is the owner of the a Tactor, to clean the Mud as the same were done by their Tractor. However, they did not clean the Mud for the reason best known to them as such one P. Inaoton Singh of the same locality further told Nongthombam Selung Singh that their Leirak was made worse by Mud.

The said Nongthombam Selung Singh replied that the same were done by him and further told that the said Leirak was not a property of Makha Leikai ancestors. Then exchange of hot words happened between P. Inaoton Singh and Nongthombam Selung Singh. On listening such hot words, the Applicant No. 1 came out from his house at his gate to look the matter but suddenly, Nongthombam Selung Singh hold the right hand of the Applicant No. 1 and dragged upto Yumnam gate and the same was escorted by Abujam Bhogendro Singh. Then Nongthombam Selung Singh without saying any words punched on the face of the Applicant No. 1 again and again thereafter, Abujam Bhogendro Singh hold the left hand of the Applicant No. 1 and let Nongthombam Selung Singh to beat the Applicant No. 1. In such a situation the Applicant No. 2 came out and tried to subside the matter however, Nongthombam Selung Singh again assaulted the Applicant No. 2 on his head by a stone with intention to cause death and sustained injuries on his head.

3. That, then the people who were present there saved/protected the Applicants No. 1 and 2 and evacuated them to the C.H.C., Yairipok for doing the needful. On the way to C.H.C., Yairipok a complaint against the above mentioned 2(two) person Nongthombam Selung Singh and Abujam Bhogendro Singh was made verbally by the Applicant No. 1 to the Yairipok Police Station. But the Officer-in-charge of the Yairipok Police Station instructed them to made a proper complaint after returning from hospital as they were injured.

4. That, the Applicant No. 1 and 2 were given treatment at the C.H.C., Yairipok, BABINA Diagnostics, Imphal, RAJ MEDICITY, Imphal and Shija Hospitals & Research Institute Pvt. Ltd., Langol. 16 (Sixteen) photocopies of the relevant medical papers and 4(four) photographs showing the injuries sustained by the Applicants are enclosed with this application for reference.

5. That, on 28-11-2025, after discharging from respective hospital the Application No. 1 for and on behalf of the Applicant No. 2 made a report to the Officer-In-Charge, Yairipok Police Station to take up necessary legal action against the above mentioned 2(two) persons and one Nongthombam Premananda Singh who is the son of Nongthombam Selung Singh as on 26-11-2025, in the evening, Nonthombam Premananda Singh also threatened the family members of the Applicant



No. 1 to face dire consequences if they made complaint to the Police regarding the matter. He further told that the Applicant No. 1 and 2 would have died if not interfered by the locality. The Officer-In-Charge, Yairipok Police Station instead of taking necessary legal action against the above mentioned 3(three) persons are trying to suppress the matter on the pretext of bringing an amicable settlement between the parties. The Officer-In-Charge, Yairipok Police Station are avoiding to take the complaint filed by the Applicant No. 1 on one or another pretext till date.

6. That, on the day of incident i.e. on 26-11-2028, after the said incident the Yairipok Police Station picked up the Tractor of the Abujamm Bhogendro Singh however after 2(two) days the same was handed over to the Abujamm Bhogendro Singh for the reason best known by the Yairipok Police Station.

7. That, the particulars of the persons who have attempted to kill and threatened the Applicants are given below:

#### PARTICULARS OF THE CULPRITS



- (i) **Nongthombam Selung Singh**, aged about 50 years, S/o (Late) Nongthombam Birmani Singh of Pechi Awang Leikai, P.S. Yairipok, District- Thoubal, Manipur.
- (ii) **Abujam Bhogendro Singh**, aged about 55 years, S/o Abujam Nimaichand Singh of Pechi Makha Leikai, P.S. Yairipok, District- Thoubal, Manipur.
- (iii) **Nongthombam Premananda Singh**, aged about 25 years, S/o Nongthombam Selung Singh of Pechi Awang Leikai, P.S. Yairipok, District- Thoubal, Manipur.

We, therefore, request to your goodself to give a direction to the Officer-in-Charge, Yairipok Police Station to take up necessary legal action against the above mentioned 3(two) culprits (i) Nongthombam Selung Singh, (ii) Abujam Bhogendro Singh and (iii) Nongthombam Premananda Singh in the above circumstances, in the interest of justice.

Please do the needful at the earliest.
