Sir,

I have the honour to state that today i.e 14/11/2025 @ 5:00 am, a random frisking and checking was conducted at **Maram PS Check gate, Lairouching along NH-2** Senapati District, Manipur by a joint teams of Maram Police Station, Senapati Police Special Operation Team and A/109, CRPF, Quick Action Team (QAT). While conducting frisking and checking, one Tata Yodha 1700 Pickup vehicle (White in colour) bearing Regd. AS18AC 4496 was seen coming from Senapati side towards Mao. The said vehicle was stopped for frisking and checking. On enquiry, the driver of the vehicle is identified as **Raju Ali (35) yrs s/o Mahtab Ali of Ghopla Kaniha, P.O-Kaniha, P.S- Kamalpur, Dist. - Kamrup, State- Assam-781380** and accompany by **Aynul Haque (40) yrs c/o Pizir Ali of Bongaon, P.O & P.S- Rangia, Dist- Kamrup, State- Assam 781354**. On checking the vehicle, suspected opium was found concealed inside the skinned body of the vehicle. As such DC/SPT was intimated by my senior officer and a request was made to depute one magistrate. Accordingly, Shri. Panii James SDO/BDO Lairouching was deputed for doing the necessary procedures.

On arrival of the Executive Magistrate and in his presence and in the presence of the suspected accused persons, the vehicle was thoroughly checked. On checking twenty packages of suspected opium were found concealed inside the skinned body of the vehicle.

The 20(Twenty) packages suspected to be opium were weighed by using weighing machine in the presence of the Executive Magistrate and witnesses weighing 18.2 kg (with plastic cover) with approximate value of Rs. 91,00,000/ (Ninety one lakh) and along with the following items were found from their possession.

1. 02 (Two) (Keypad Mobile Phone):

- LAVA (keypad mobile phone) having IMEI 1: 359738384865251 and IMEI 2: 359738384865269 with one Airtel Sim card No. 9957658872.
- ITEL (keypad mobile phone) having IMEI 1: 355965770756968 and IMEI 2: 355965770756976 with one Airtel Sim card No. 8099071482.

2. 02 (Two) Aadhar Card:

- Aynul Haque - 877724944605.

Thereafter, the 02 (two) individuals and above items were handed over to the OC/MRM-PS for taking further necessary legal action please.
