I have the honour to report that today i.e. 02-12-2025 in between 6:40 pm to 7:10 pm, my cousin brother namely Sanasam Uttamkumar Singh (42) yrs S/o S. Gopeshwor Singh of Thoubal Sabaltongba Mamang Leikai was physically assaulted by an unknown persons while he was at Thoubal Sekpi Khongnangkong. Further, the unknown person stabbed by using a knife on the neck of my cousin brother without giving proper reason. As a result, my cousin brother was sustained serious injuries on his person and evacuated to District Hospital, Thoubal and further refer to Raj Medicity Hospital, Imphal.
