11. First Information contents: Today i.e. 06/12/2025 at 06:10 pm, received an information that, on the same day at about 05:50 pm, one vehicle Tata Tiago car b/regn.no. MN06LA 0692 proceeding from Imphal towards Thoubal side collided with one Diesel Auto Rickshaw b/regn.no. MN01L2670 which was proceeding into the opposite direction i.e. from Thoubal towards Imphal side along NH-102 at Waithou Tronglaobi, Thoubal due to rash or negligent driving on the part of both unknown drivers of both vehicles. As a result of it, unknown driver of the said Diesel Auto Rickshaw b/regn.no. MN01L2670 including it's three other occupants sustained severe injuries and evacuated to the hospital for medical treatment. Both vehicles were also partly damaged. Hence the case.
