I have the honour to report that today i.e. 09-12-2025 at around 8:30 am, three individuals namely (i) Md. Akil (45) yrs S/o (L) MV. Babu, (ii) Md. Samim (35) yrs S/o -do- & (iii) Md. Ahesan (20) yrs S/o Md. Akil, all are resident of Keibung Mayai Leikai, chase me by holding sticks without proper reason, while I was on my way home by driving my car Amaze B/Regn. No. MN01AG4874 after buying some articles from Keibung Bazar. On reaching at Keibung Mayai Leirak Makok, they forcibly stopped me and physically assaulted by using sticks. As a result, I sustained injury on my body and evacuated to District Hospital, Thoubal for medical treatment.

It is, therefore, requested to kindly take up necessary legal action against the above three individuals.
