

I have the honour to report an incident that occurred today i.e. 11/12/2025 at around 1.30 pm at Irong Thokchom, Thoudam Thoubal. That, following an altercation regarding obstruction of an undergoing repairing works of Thoudam Moirang Sanggoi Mapal L/P Madrassa School, Irong Thokchom Thoubal. The following individuals (1) Mrs. Thoinu (45) yrs W/o Ayub Khan, (2) Md. Nawaz Sharif (28) yrs S/o Abdul Latif, (3) Md. Akhter Hussain (33) yrs S/o (L) Abdul Latif, (4) Md. Ibotomba (65) yrs (L) Abdul Helim, (5) Md. Naushad Khan (27) yrs S/o Abdul Latif, (6) Md. Mirza Galib (26) yrs S/o Abdul Latif & (7) Md. Tarique Hussain (30) yrs S/o Abdul Latif all residence of Irong Thokchom, Thoubal were physically assaulted by the undernoted individuals using wooden stick, iron rod, spade and knife etc by coming towards our house located at Irong Thokchom, Thoudam Thoubal. As such, the above mentioned individuals received injuries on their persons and evacuated to Amina Hospital & Research Institute Lilong and refer to Higher Hospital for medical treatment.
