Subject : REPORT.

Respected Sir,

I, the undersigned have the honour to state the following few lines for your kind perusal and prompt necessary action.

At about 11.00 am of 11.12.2025, I was coming out of my residence on my two-wheeler vehicle with Mahmood son of Apikpa resident of Irong Thokchom Thoudam Moirang Sangol Mapal on his own separate vehicle. Reaching near School i.e., Irong Thokchom Thoudam Moirang Sangol Mapal LPM School, one Md. Ibotomba Ex Head-Master (i/c), Thoudam Moirang Sangol Mapal LPM School and resident of Irong Thokchom Thoudam Moirang Sangol Mapal and Md. Islamuddin son of Late Abdur Rahim of Irong Thokchom Thoudam Moirang Sangol Mapal stopped the vehicle of Mahmood which was ahead of me. I also stopped my vehicle as we were coming together.

The said two persons asked for key of the said school to Mahmood. Mahmood replied he cannot open the school without the permission of Md. Firoj Khan, Headmaster (i/c) of Thoudam Moirang Sangol Mapal LPM School. Then, the said two persons asked me to open the said school as I am the younger brother of the said Headmaster (i/c) of the said school. I also told them I have no authority to open the said school nor I am related to the said school.

Suddenly, Nawaz Sharif son of Abdul Latif, Mirza son of Abdul Latif, Noussad son of Abdul Latif, all residents of Irong Thokchom Thoudam Moirang Sangol Mapal who seem to accompany Md. Ibotomba had a heated argument with Mahmood. They (Nawaz Sharif, Mirza and Noussad) dragged down Mahmood and started beating him. I intervened to stop the beating of Mahmood by them. They also threatened me not to interfere them. Anyhow, I rescued Mahmood and brought him to his home.

At Mahmood's home, he was given first aid by his family members. Mahmood's father Apikpa was quite shocked why his son was beaten by them. And after some discussion at Mahmood's residence, he (Apikpa) decided to know why Nawaz Sharif, Mirza and Noussad who had beaten his son. So, Apikpa



with Mahmood along with his family members went to the residence of Nawaz Sharif, Mirza and Noussad and I along with my brother Yaqoob who also came there hearing about the beating of Mahmood also accompanied them.

Suddenly Apikpa and Mahmood was attacked and beaten by Md. Ibotomba, son of Late Abdul Halim, Nawaz Sharif son of Abdul Latif, Mirza son of Abdul Latif, Abdul Khalique son of Late Abdul Halim, Noussad son of Abdul Latif and Tarique son of Abdul Latif, Bicky daughter of Abdul Khalique, Bembem daughter of Ayub Khan, Thoinu wife of Ayub Khan, Akhtar son of Abdul Latif, Sana wife of Abdul Khalique, all residents of Irong Thokchom Thoudam Moirang Sangol Mapal and some others holding deadly weapon (swords and iron rods) at the main road near their Gate. I along with my brother (Yaqoob) tried to stop the beating, but we were also beaten by the above name persons. Suddenly Nawaz Sharif son of Abdul Latif, and Ayub Khan son of Late Abdul Halim, all residents of Irong Thokchom Thoudam Moirang Sangol Mapal fired guns and continued beating us. I lost my consciousness and was first treated at PHC, Mayang Imphal by stitching on my forehead and then was directed to go RIMS for further treatment and discharged at 1.00 am of 12.12.2025 from RIMS.

Later on I was informed by my mother that on 11.12.2025 at about 3.00/3.30 pm, a team led by Md. Ibotomba Ex Head-Master (i/c), Thoudam Moirang Sangol Mapal LPM and resident of Irong Thokchom Thoudam Moirang Sangol Mapal holding guns and deadly weapons (guns, swords, iron rods and sticks) by Nawaz Sharif son of Abdul Latif, Ayub Khan son of Late Abdul Halim, Abdul Khalique son of Late Abdul Halim, Mirza son of Abdul Latif, Noussad son of Abdul Latif, Tarique son of Abdul Latif, Sana wife of Abdul Khalique, Fatima daughter of Abdul Latif, Abdul Latif son of Late Abdul Halim all residents of Irong Thokchom Thoudam Moirang Sangol Mapal and some others came to my residence at Irong Thokchom Thoudam Moirang Sangol Mapal and called out me and Yaqoob threatening to kill us and down our home. At that relevant time, I and my brother were not at home.

Again, I was admitted to RIMS on 12.12.2025 in the evening and undergoing treatment there.

Now I am quite afraid of myself and my family members lives. I was in shock and paranoid as such I did return home immediate after my discharge from RIMS. And due to pain over my body and pain I rest to stabilize my body.

After thinking over the unlawful matter and encouragement from my family, I am lodging this report against the person's named above for the offence of grievous hurt, wrongful restraint, force, and criminal intimidation with deadly weapons including guns which are punishable under law.

Now, I am in constant fear that any untoward accident will happen to me and my family members at any time.

So, I earnestly request your good self to take appropriate legal action as per law and to punish ~~him~~ ^{them} appropriately.
