12. First Information contents:

Today, i.e. 07/12/2025 at around 07.42 pm received an information that on the same day at around 07.35 pm one Tata Yodha, white in colour bearing registration No. WB25J-6890 driven by an unknown driver plying from Wangjing side towards Khongjom side collided to a Eeco Van, white in colour bearing registration No. MN04P-2506 driven by unknown driver plying to opposite direction along NH No. 102, near Dhaka Checkon due to rash and negligent driving on the part of Tata Yodha. As a result, the driver and one occupant of Eeco van and unknown driver of Tata Yodha sustained injuries on their persons and evacuated to District Hospital Thoubal for medical treatment, however the driver of Eeco Van succumbed due to his injuries. Both the vehicles were also badly damaged.

Hence a regular suo-moto case under FIR No. 55(12)2025 KJM-PS U/s 281/125(b)/324(4)/106(1) BNS, 2023 has been registered for investigation.
