11. First Information contents:

In continuation of 'War on Drug', a combined team comprising of Ukhrul District Police, 4th Mahar Regiment, G-Coy 132 Bn BSF, Forest Department Ukhrul, NAB, Executive Magistrate LM-Block and Committee Against Poppy Plantation(village volunteer) led by DSP(CAR)/UKL conducted destruction drive of illegal poppy plantation from 11/11/2025 to 15/11/2025 at Lamlai Chingphei-Shongphei-Mullam hill ranges, Latitude – 25.020651°N and Longitude – 94.208377°E, under the supervision of Superintendent of Police, Ukhrul. During the poppy destruction drive, an area of about 03(three) acres on 11/11/2025, 30(thirty) acres on 12/11/2025, 35(thirty-five) acres on 13/11/2025, 36(thirty-six) acres on 14/11/2025, and 35 on 15/11/2025 were destroyed. A total area of 139(one hundred thirty-nine) acres of poppy plantation was destroyed which is expected to yield about 1,251 kg of opium (9kg per acre). No cultivator was found in the field and no arrest was made during the destruction drive. Seized some suspected poppy pods from the field for adducing evidence.

Hence, a regular case on suo-motu under FIR No. 7(11)2025 LTN-PS U/S 18(b) ND & PS Act, has been registered for investigation.
