Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Loitang Khullen Maning Leikai area. During search at the house of one (L) M. Binomadhoh Singh located at Loitang Khullen Maning Leikai, Imphal West District, one unknown person was found who later identified himself as Maibam Nanao Singh (49 yrs.) @ Kokngang @ Bungo S/o. On further verification, he disclosed that under the instruction of his commander Thonglenjao, he is involved in extortion activities by serving monetary demands/threats to government officials located in and around Imphal area.

On spot checking, the following articles were recovered from his possession:

- (1) One Redmi Note 9 Pro Max mobile handset along with one Jio SIM card bearing mobile number 9863639600 (as disclosed by him),
- (2) one Nokia keypad mobile handset along with one Airtel SIM card bearing mobile number 7085394306 (as disclosed by him) and
- (3) one brown wallet containing a sum of Rs. 500/- (rupees five hundred only).

Hence, he was arrested from the spot at 02:20 pm whereas seizure of the above recovered articles could not be done at the spot since a mob consisting of Women folks and local youths started gathering at the spot and caused obstruction to the police team.
