On 28 Nov 2025, at approximately 1730 hrs, a white-coloured Creta Vehicle, bearing Registration No. MN 01 AW 1282, was stopped for routine checking while crossing the Mobile Vehicle Check Post (MVCP) at Phaikoh COB. The vehicle was travelling from Nampisha side towards Phaikoh vllage. During routine checking of the vehicle and inquiry with the driver, the occupants exhibited suspicious behavior and were unable to provide satisfactory answers regarding the purpose of their visit. Upon further search of the vehicle, conducted by duty personnel a cash in Indian currency accounting to approximately Rs. 57,77,700/- is recovered as under:
