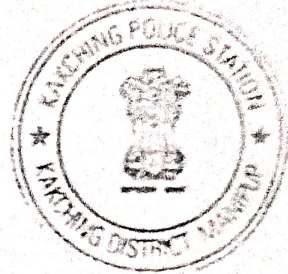

I have the honour to report that today i.e. 15/12/2025 at about 03:30 p.m. received specific information by SAFE/TBL (special action force for extortion) that some active cadres of PREPAK(Pro) a banned unlawful Organisation is loitering in and around Pallel Bazar area. Acting on the information, organised a joint team of Commando Unit, Thoubal led by Insp. K. Nitranjan Singh, OC/CDO, Thoubal under the supervision of Shri H. Devendra Singh, Addl. SP(Ops.), Thoubal and under the overall supervision of Shri. Manoj Prabhakar M, IPS, Superintendent of Police, Thoubal and one column each of 33 & 46 AR immediately rushed to Pallel Leimai Chingjin and conducted frisking and checking of suspected person..

While conducting frisking and checking detained one unknown person who identified himself as Wairokpam Achouba Meitei @ Achetpa 21 yrs S/o. W. Rabi Meitei of Heirok Part-III, Inganglok an active cadre of PREPAK(pro), a banned unlawful Organisation.

On his body search one Redmi Note 8 along with Jio SIM card bearing mobile No. 7814657622 were recovered from his possession.

On verification, he disclosed that he joined PREPAK(Pro) in the year, 2023 through one Naoba of their organisation. He got 15 (fifteen) days basic military training at Phayeng and working under the command of s/s. 2<sup>nd</sup> Lieutenant Abujam Hemchandra Singh @ Naoba @ Pandamba of their organisation. He is providing logistic support to his organisation.

Hence, he was arrested at 05:20 p.m. of 15/12/2025 from Pallel Leimai Chingjin near bridge by observing formalities and seized the above mentioned Redmi Note 8 along with Jio SIM card bearing mobile No. 7814657622 at 06:06 p.m. of the same day at DHQ Thoubal by observing formalities.

It may be mentioned that all the necessary formalities under BNSS i.e. preparation of seizure memo and arrest memo by taking videography could not be done at the spot as an information was received from intelligence sources that some members of the above said unlawful organisation may attack or some organised public mob may be initiated to forcefully free the arrested accused person. Hence, all the documentation works were prepared at DHQ, Thoubal at about 06:15 p.m. of the same day and recorded through e-Sakshya portal.

The arrested person mentioned above along with the seized articles is being handed over to you for taking further necessary legal action against him.
