I have the honour to report that today, i.e., 19/12/2025 at about 04:30 p.m., a team of CDO Unit, Kakching, under the command of Subedar Ksh. Prakash Singh, i/c OC, CDO Unit, Kakching, and under the supervision of Shri Amarjit Laishram, MPS, Addl. Superintendent of Police (Ops), Kakching, and overall supervision of Smt. Priyadarshini Laishram, IPS, Superintendent of Police, Kakching, conducted frisking and checking at along NH-102 Imphal Moreh road at Kakching Lamkhai by establishing a mobile check point as part of precautionary security measures in the district.

During the frisking and checking, one unknown individual was noticed coming on foot from Pallel side towards Sora side in a highly suspicious manner. Due to his suspicious behaviour, the individual was detained at the spot for verification.

On preliminary questioning at the spot, he identified himself as Thokchom Momocha Meitei @ Lamngakpa (28 years), S/o Th. Amuthoi Meitei of Nongada Awang Leikai, Imphal East.

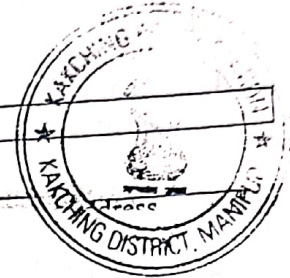

Thereafter, he again joined the banned organisation KCP (MFL) in the month of January 2024 and is presently holding the rank of S/S 2nd Lieutenant. He also disclosed that he is serving as an instructor for newly recruited cadres at Tamu, Myanmar, for the said banned organisation and that he recently ran out from Tamu (Myanmar) on foot. It is highly suspected that he may be involved in various subversive activities carried out by the banned organisation.

On the above admission, the said individual was arrested from the spot at 06:02 p.m., after observing all legal formalities, and videography of the arrest was done at the spot.

The arrested individual, along with the arrest memo, arrest intimation, and grounds of arrest, are handed over to you for further necessary legal action, please.
