Subject: Complaint regarding Physical and Mental Harassment by my Husband and In-laws.

Sir.

I, the undersigned complainant, most respectfully submit this complaint seeking your urgent intervention.

- 1. That, I got married to my husband/accused, Haobam Jotin Singh, in the month of July 2009. After married, we were blessed with two minor sons.
- 2. That, to my utter shock and surprise, in the first week of April 2025, my husband/accused repeatedly revealed that he had been maintaining an illicit relationship with one Khumujam Indrani Devi of Nongpok Keithel Manbi, Yairipok, and that he intended to live with her as his second wife. When I did not agree to such an unlawful demand, my husband began to ill-treat me without any reason, causing me severe mental anguish.
- 3. That, in the first week of May 2025, my husband and in-laws told me to either leave my matrimonial home or allow him to marry the said woman as a second wife. When I refused, they started to torture me both physically and mentally without any justifiable cause. My husband slapped me multiple times and even hit me with his sandal on my face. Despite witnessing these acts, my in-laws never intervened.
- 4. That, in the month of August 2025, while I was still residing in my matrimonial home, I unexpectedly received a summons from the Ld. Family Court, Thoubal, being Matrimonial (Divorce) Suit No. 21 of 2025, directing me to appear on 4th September 2025. When I questioned my husband about filing the divorce case, he instructed me not to appear before the Court. However, I appeared along with my two minor sons and narrated the incidents of harassment before the Hon'ble Court. The Court advised me to engage an Advocate for defending my case.
- 5. That, after returning home from Court on 4thSeptember 2025, my husband/accused beat and thrashed me mercilessly and attempted to throw me out of the house. Local residents



intervened upon hearing the commotion. However, around 1:30 AM on 5th September 2025, my husband and in-laws forcibly took me and my sons to my parental home. Upon receiving the information, the local residents assembled and discussed the matter, after which my husband and in-laws agreed to take us back after a few days. Shockingly, my husband never returned to take us back, and whenever I contacted him, he rudely stated that he would not allow us to return to the matrimonial home.

- 6. That, my husband/accused is presently serving as a Rifleman in the Manipur Rifles. bearing Rifleman No. 05197126, of the 5th Battalion, Manipur Rifles.
- 7. That, on 04-09-2025 at about 9:30 PM, I was beaten, abused, and thrown out of the house by my husband due to his constant pressure for divorce. As a result of these continuous acts of cruelty, I am presently living under severe stress and emotional trauma.
- 8. That, the acts committed by my husband/accused constitute offences punishable under Section 85, Section 351(1) & (2) & 3(5) of the BNS, 2023.

Hence, in view of the above facts and circumstances, I earnestly request you to kindly register an FIR against my husband and in-laws on the basis of this complaint and take necessary legal action.
