Sir,

I have the honour to report that today i.e. 18/11/2025, on receiving a reliable information, combined team of CDO Unit KCG led by Inspt. Parlung Arthur Roel, One column of 33 AR, a team of 19th Garhwan Rifle and a team of Kakching PS led by ASI Md.Baseeruddin, assisted by Sub. S Birla Singh, OC/CDO Unit Kakching and under the supervision of Shri Amarjit Lamabam MPS, Addl. SP(Ops), Kakching and under the overall supervision of Shrimati Priyadarshini Laishram, MPS, SP-KCG, conducted Joint search operation at Kharungpat Marin, Baffalo Farm area from 05.30 am to 07.10 am. During the joint search operation, the area was cordoned off and search was conducted at the suspected places of Kharungpat Marin, Baffalo Farm areas. On searching the area, the following items containing in White sack mark as "TOP MAYANMAR SUPER QUALITY PP BAG" and which seems to be kept concealed by unknown armed miscreants have been recovered from a secluded area of Kharungpat Marin Baffalo Farm. Details of the recovered items are:-

1. One AK-47 Rifle with empty Magazine,
2. One Single Barrel,
3. One Bolt Action Single Barrel Regd. No. 2076A.
4. One Pistol with empty magazine Mark as "CZ75B MADE IN CZECH REPUBLIC",
5. One Pistol with magazine loaded with 2 rds. Regd. No. INUSA 32
6. One Handset without Battery with charger.
7. One tear smoke Grenade.
8. Three nos. of tear smoke shell (normal).
9. Five nos. of Detonator with wire.
10. Seven nos. of IDL explosive Class-II.
11. One tube launching.
12. One no. of HE .36 grenade without detonator.
13. One no. of HE .36 grenade without lever & detonator.
14. One pair of boot.

Accordingly, the recovered items were seized at 06:04 am of 18/11/2025 at the spot by observing formalities as per provision u/s 106 BNNS. The seized items along with the copy of seizure memo are being handed over for taking further necessary legal action.
