I have honour to report that today i.e. 22/11/2025 at around 0600 hrs. received a reliable input about the movement of some members of banned organization RPF/PLA along Indo Burma Sugnu road. On receiving the information teams of CDO Unit, kakching conducted frisking and checking at kakching police Station Gate by establishing a Mobile check point under the command of Sub. S. Birla Singh, OC-CDO Unit, Kakching and under the supervision of Shri Amarjit Lamabam, MPS, Addl.SP (Ops), Kakching and overall supervision of Smt Priyadarshini Laishram, MPS, Superintendent of Police Kakching District. During the frisking and checking detained one i10 Car bearing registration No. MN04P-4578 (white in colour). On checking of the vehicle the driver was identified as Yumnam Romen Singh (47) S/o. Y. Angangyaima Singh of Lamjao Mayai Leikai, cousin brother of the occupant and occupant namely Yummam Jayentakumar @ Tomba Singh (52)yrs S/o. (L) Y. Tamu Singh of lamjao Mayai Leikai, Kakching District. During the checking the occupant was seen to be in a very suspicious manner. Due to his suspicious nature the said individual was detained for verification.

On verification the detainee was identified as one Yumnam Jayentakumar Singh @ Tomba Singh (52)yrs S/o. (L) Y. Tamu Singh of lamjao Mayai Leikai, Kakching District. On questioning he disclosed that he is an active cadre of banned organization RPF/PLA and works under the command of S/S Major Krishna of the said organization. On his command (Krishna) he advised to Yumnam Jayentakumar Singh @ Tomba Singh to concealed arms and ammunitions belonging for the said organization. From his admission he was arrested at the spot at 07:30 hrs by observing formalities and videography of the same was done at the spot.

On further questioning he stated that he had concealed some Arms and ammunitions at his farm located at Hiyanglam Mamang Pat. Following the disclosure, teams of CDO Unit, Kakching, led by Addl. SP (Ops), Kakching assisted by OC/CDO Unit, Kakching Sub. S. Birla Singh, Sub. Ksh. Prakash Singh, HC K. Nepolian Singh, HC N.
