Today, i.e. 15/12/2025 at 12.30 a.m, received an information that on the same day at about 12.10 a.m, one Maruti Alto (silver in colour) B/R No. MN01W 6947 coming from Wabagai Bazar side towards Phoubakchao Bazar, Imphal West, District driven by Nanao Irengbam aged about 33yrs. S/o I. Manihar Singh of Phoubakchao Awang Leikai dashed over at the right side of Maruti Gypsy Bearing Registration No. HR-26R-4138 (white in colour) when it was parked near the gate of Keisham Sumanta Singh and also dashed over one pedestrian namely Keisham Sumanta Singh aged about 34yrs. S/o K. Rajkumar Singh of Sekmajin Ningolkhong due to rash and negligent driving. As a result of which, the pedestrian received serious injury on his person and evacuated to Raj Medicity Hospital, Imphal for medical treatment. Both the vehicles i.e Maruti Alto (silver in colour B/R No. MN01W 6947 & Maruti Gypsy Bearing Registration No. HR-26R-4138 (white in colour) were also partly damaged.
