During the search operation, one unknown individual matching with the input was detained at a hut located at Waikhong Maning Pat area.

On spot questioning, the individual identified himself as Thounaojam Subhashchandra Meitei aged about 42 yrs S/o Late Th. Manihar Meitei of Wabagai Leirak Achouba, Kakching District, A/P- Waikhong Tangsam Leikai under Waikhong PS.
