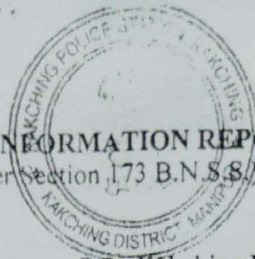

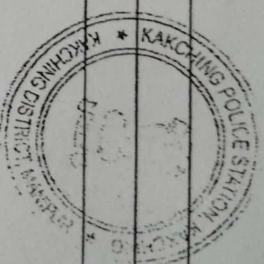

On receiving the information as per routine a mobile check point was established at Kachching Lanikai along Indo Burma Sugnu road to take precautionary measures. During the frisking and checking one Auto (diesel) coming from Kachching Bazar towards Sora was detained. During the detention, the said driver of the Auto (diesel) was found to be in a very suspicious manner. Due to his nature the said driver was verified at the checking point.

On preliminary questioning, he identified himself as Wangkhem Chinglen Singh 29yrs. S/o W. Manao Singh of Langthabal Khunou, Thoubal District.


