Today, i.e. 05/12/2025 at 3.10 p.m, received an information that on the same day at about 3.10 p.m, one Tata Magic (white in colour) B/R No. M01W 4045 coming from Sekmaijin Bazar side towards Wabagai Lamkhai Bazar driven by unknown rider and one Tata Xenon (Silky Silver in colour) B/R No. MN02B 5056 which was coming from opposite direction i.e. towards Sekmaijin Bazar side driven by unknown rider were collided each other due to rash and negligent driving on both the unknown riders. As a result of which, some labour who were sitting on the Tata Xenon (Silky Silver in colour) B/R No. MN02B 5056 were received injury on their person and evacuated to Hospital for medical treatment. Both the vehicles i.e. Tata Magic (white in colour) B/R No. M01W 4045 & Tata Xenon (Silky Silver in colour) B/R No. MN02B 5056 were also partly damaged.
