Today i.e. 24/11/2025 at 2:15 pm received a reliable information that the rally organized by Internally Displaced Persons (IDPs) around 500 members of Dolaithabi, Sadu Yengkhuman, and Ekou villages at Pukhao Terapur protested against the ongoing Manipur Sangai Festival, 2025, citing unresolved resettlement issues amid the ethnic clashes in Manipur, turned violent and unruly at around 11:40 am of the same day, where the mob attempted to enter Dolaithabi village (restricted area in connection with the ongoing ethnic clash) without permission.

The mob, despite giving maximum warning, started pelting stones and catapulting to the security personnel on a duty in which some security personnel got injured further damaging the Government vehicles i.e. DI TATA bearing registration No. MN01S 5676 of SMG-PS, 02 vehicles registration no. MN 01 AK 3725 (scorpio) and MN 06 LX 6550 (New Bolero) of G/169 Bn. CRPF, one Gypsy bearing registration no. MN01W 1940 of CDO-IE and other security personnel vehicles as well.
