Act</u></p> <p>On 02/11/2025 at about 03:00 p.m Laipubam Rameshchandra Sharma, Havildar of CDO, Unit Thoubal received complaint from the locals of Moijing Amakcham Leikai that two unknown persons had threaten locals with weapons for prejudicial activities like extortion, monetary demand and they proceeded towards Lilong Nungei. Acting on the information, a joint team of CDO Unit, TBL led by Insp. K. Nitarnan Singh, OC CDO, Thoubal under the supervision of Shri H. Devendra Singh, Addl. SP(Ops.), Thoubal and under the overall supervision of Shri. Manoj Prabhakar M, IPS, Superintendent of Police, Thoubal and a column of 33 AR immediately rushed to Lilong Nungei area at around 03:20 p.m. In that, two unknown persons were seen in a very suspicious manner and they were detained at along the IVR of Lilong Nungei for verification. On preliminary verification, the unknown persons identified themselves as 1) Chabungbam Arjun Singh @ Khoimu (50 yrs) S/o. (L) Ch. Inaocha Singh of Mayang Imphal, Konchak, Imphal West District and 2) Md. Najir Khan @</p>	-	-	-



			received a reliable information input from 2 MAHAR corroborated with own source regarding about the movement of some armed miscreants who were involved in extortion activities from general public, local businessmen, government institutions etc, at Khongjom Papal Maning Leikai area, Thoubal District. Based on the input, immediately, a combined team of CDO-BPR led by self assisted by ASI H. Robash Singh and civil teams of CDO-BPR along with one team of CDO-TBL led by HC M. 
