Sir,

I have the honour to report that on 19/06/2025 my son namely Mayanglambam Niraj Singh (18) S/o M. Khelen Singh of Nongpok Kakching Mayai Lekal had eloped with Khangenmayum Tarubi (24) D/o Kh. Tiken of Sanjenbam Khunou. So, both families jointly fixed their marriage on 04/02/2026.

However, my son later eloped with another girl namely Saikhom Penaobl of Khongjom on 04/12/2025. Upon hearing this, the parents of Khangenmayum Tarubi called me to their residence to discuss the marriage which had been earlier fixed.

Therefore, today i.e. 06/12/2025 at around 11:00 am, I along with 10(ten) members of my relatives including my wife namely Mayanglambam Naoton Devi (47) visited Khangenmayum Tarubi's house located at Sanjenbam Khunou as requested by her parents to discuss the matter regarding the marriage.

On arrival at Khangenmayum Tarubi's residence, her father namely Khangenmayum Tiken S/o Kh. Chingku of Sanjenbam Khunou, Lane No. 4, Imphal East and his associates threatened me by stating that he would shoot me. Instead of discussing about marriage date, her family members held captive all the 10(ten) members whom I was accompanying without giving any reason. I was released by them on the condition that I shall have to bring damages amount of Rs. 50,00,000(Fifty lakhs) caused to his daughter.

It is therefore requested to kindly take up necessary action to rescue those 10(ten) persons.
