12. First Information contents:

Subject: Report.

Sir,

I have the honour to state that on 15/12/2025, a reliable information was provided by YADAM which was further corroborated by ANTF Imphal East Unit, about the presence of a certain individual who was involved in the distribution of narcotic drugs in the locality of Sawombung Tejpur area. The said information was reduced in writing and was placed before Shri Ak. Sadananda Singh, Addl. SP (Traffic) Imphal-East (Nodal Officer ANTF Imphal-East) for executing the information. I obtained the authorization to search the said area from Addl. SP (Traffic) Imphal East.

On approval of the source report, a joint team comprising of ANTF Imphal East Unit, CDO Imphal East Unit (O-22) and team of Range Imphal QAT and M & N Sector CRPF was constituted for execution of the secret information. Accordingly, a random frisking and checking was conducted at Sawombung Tejpur Highway with combined team of Range Imphal QAT and M & N Sector CRPF from 1:00 pm.

In that, on preliminary verification one Suimi Awungshi aged around 53 years, s/o (L) Tungsing Awungshi, r/o Muirei Village, Ukhrul District a/p Sawombung Khunjao was detained on the spot at around 1:50 pm for further checking and verification. As per lawful procedure, we identified our identities as police personnel of ANTF, Imphal East.

Further, I told him that his belongings needed to be searched. On being asked whether he would like to search before a Gazette Officer or before a Magistrate. None of the civilians available at the spot were willing to be witnesses, so I asked my police party, in particular, who accompanied me to be the witnesses. Thereafter, in presence of the Executive Magistrate and witnesses conducted search his side-bag black in colour.

Furthermore, after informing Add. SP/Traffic Shri Ak. Sadananda Singh (MPS) (In-Charge, Anti Narcotic Task Force/IE) the side bag was searched in the presence of the Executive Magistrate of IE viz. Smt. Sapam Nirva Devi, SDC/Sawombung.

During the search, one plastic polythene bag suspected to contain brown sugar was found concealed in the side-bag (black in colour), a Redmi mobile phone was also found from his possession. On Weighing the said plastic polythene containing suspected Brown Sugar using a weighing machine, it was found to weigh about 1(One) Kg(approx.)

Thereafter, by observing the formalities, the following items were seized on the spot at 2:15 pm and the detainee was also arrested from the spot at 2:20 pm. Details of the seized items are as follows:

- 1) one plastic polythene bag suspected to be containing brown sugar, weighing about 1(one) Kilogram.

- 2) one Redmi 10 Prime mobile phone, Model No. 21061119BI (IMEI No. 1: 868480055548718, IMEI No. 2: 868480055548726) along with one Airtel Sim Card bearing phone No. 8415913010.

It is therefore, the arrested accused person namely, Suimi Awungshi aged around 53 years, s/o (L) Tungsing Awungshi, r/o Muirei Village, Ukhrul District a/p Sawombung Khunjao along with the seized articles are being handed over to you for taking up necessary legal action against him.
